



WAIVER, RELEASE AND CONSENT FORM

I, _____, hereby release and discharge the organizing committee, CYCLING JORDAN and BOOST, their principles, all sponsors, representatives and volunteers of THE100 Annual Cycling Challenge from any and all liability, causes of action, suits, debts, contracts, agreements, claims and demands whatsoever as a result of my participation in THE100 challenge.

I understand that accidents, fatalities, serious bodily injuries and/or property damage can occur while participating in the race. Knowing the risks involved, I agree to assume those risks and to release all of persons or entities mentioned above from liability for any injury, death, illness or property damage accruing while participating in this event or in the travel to and from the race site.

I agree that I will use good judgment, be self-reliant and stop to request assistance if I am unsure of my ability to complete any segment of the race safely.

I attest that I am physically fit and that I also agree to wear a bicycle helmet at all times when riding a bicycle during this race.

If I decide to leave or I am asked to leave the race early and I do not complete the event as planned, I assume all risks inherent in leaving and waive all liability against the organizing committee, CYCLING JORDAN and BOOST, their principles, all sponsors, representatives and volunteers of THE100 Annual Cycling Challenge, arising from that decision. Likewise, if the organizers have concluded the tour, and I decide to go forward without the race organization, I assume all inherent in my decision to go forward and waive all liability against the organizing committee, CYCLING JORDAN and BOOST, their principles, all sponsors, representatives and volunteers of THE100 Annual Cycling Challenge arising from that decision. I agree that if any portion of this form is found to be void or unenforceable, the remaining portions of the agreement shall remain in full force and effect.
